#### **Attendance Requirements**

# **Entrance Requirements**

The school does not discriminate based on race, sex, religion, ethnic origin, or disability. Prospective students must have a high school diploma or equivalency diploma to be accepted for enrollment.

Prerequisites:

- Introduction to Cosmetic Injection Therapy Training: Must have an Esthetician, Cosmetologist, MD, NP, or Registered Nurse License
- Laser Training: Must have an Esthetician, Cosmetologist, MD, NP, or Registered Nurse License
- Permanent Makeup Training: Licensed Esthetician or Cosmetologist
- Advanced permanent makeup courses require the completion of a 132-hour Permanent Makeup course.

#### **Enrollment Procedures**

Prospective students may enroll anytime. Late enrollments will not be accepted.

#### **Postponement of Start Date**

Postponement of a starting date, whether at the request of the school or the student, requires a written agreement signed by the student and the school. The agreement must set forth:

- a. Whether the postponement is for the convenience of the school or the student, and;
- b. A deadline for the new start date, beyond which the start date will not be postponed.

If the course is not commenced, or the student fails to attend by the new start date outlined in the agreement, the student will be entitled to an appropriate refund of prepaid tuition and fees within 30 days of the deadline in accordance with the school's refund policy and all applicable laws and rules concerning the Private Occupational Education Act of 1981.

#### **Placement Assistance**

**Elite Aesthetics Academy** offers employment assistance to graduates through job lead referrals and job skills development. While assisting in your job search, we make no guarantee, expressed or implied, of future employment. Current law prohibits any school from guaranteeing job placement as an inducement to enroll students.

#### VA Student Records

VA students' records must be kept for 3 years following the ending date of the last period certified to VA. Referenced law: Title 38 CFR 21.4209(f))

# **Progress Policy**

Students must maintain an 85% grade point average. Students are aware of their progress during the course in real-time as chapter reviews, exams, and model work are completed. There is no probation policy or period. The student may be terminated if grades are not satisfactory. Termination shall be at the school Director's discretion if there are extenuating circumstances such as health or family emergencies. In this event, students will be allowed to continue with a new completion plan in place.

At the 7-day mark for the full-time 132 permanent makeup course, students will be issued progress reports with grades. Students enrolled in short-term courses will be issued grades at the course end.

Every 10% percent of completion for the 600-Hour Esthetician Program, students will be issued progress reports with grades.

# **Conduct Policy**

All students are expected to act maturely and are required to respect other students and faculty members. Possession of weapons, illegal drugs, and alcohol of any kind is not allowed at any time on school property. Any violation of school policies may result in permanent dismissal from school.

# Dismissal

Any student may be dismissed for violations of the rules and regulations of the school, as set forth in school publications. A student also may be withdrawn from classes if he or she does not prepare sufficiently, neglects assignments, or makes unsatisfactory progress. After consultation with all parties involved, the director makes the final decision.

The Director of Education may temporarily suspend students whose conduct is disruptive or unacceptable to the academic setting. After appropriate counseling, students who demonstrate a genuine desire to learn and conform to school standards of conduct may be allowed to resume attendance. The director will review each case and decide upon re-admittance.

# Facilities

The school is located at 695 S Colorado Blvd St 300 Denver, CO 80246. Our classroom and treatment areas are furnished with modern hydraulic chairs, trolleys, equipment, and supplies. Charts, diagrams, and videos to enhance classroom activities are available.

# **Previous Credits**

Credits from another institution will be evaluated on a case-by-case basis. Elite Aesthetics Academy does not guarantee the transferability of our credits to another institution unless there is a written agreement with another institution.

# **Student Grievance Procedure**

In the event an applicant, student, graduate, former student, or other parties who has business with the Academy feels his/her rights have been violated, the following procedure should be followed:

- 1. The individual must first try to resolve the issue with the other person involved.
- 2. If the matter is not resolved, the individual must attempt to resolve the issue through the Director of the school. The individual should submit a written complaint along with the required resolution to the Director. If an email is sent, please include the letter as an attachment. Please allow the Director 72 hours to respond. The Director will set a meeting to speak on the grievance and come to a resolution.

# **Student Complaints**

Attempting to resolve any issue with the School first is strongly encouraged. Complaints maybe filed by a student or guardian at any time online with the Division of Private Occupational Schools (DPOS) within two years from the student's last date of attendance or at any time prior to the commencement of training at <u>http://highered.colorado.gov/dpos</u>, 303-862-3001.

# **Refund Policy**

Students not accepted to the school are entitled to all moneys paid. Students who cancel this contract by notifying the school within three (3) business days are entitled to a full refund of all tuition and feespaid. Students, who withdraw after three (3) business days, but before the commencement of classes, areentitled to a full refund of all tuition and fees paid except the maximum cancellation charge of \$150.00or 25% of the contract price, whichever is less. In the case of students withdrawing after the commencement of classes, the school will retain a cancellation charge plus a percentage of tuition and fees, which is based on the percentage of contact hours attended, as described in the table below. The refund is based on the official date of termination or withdrawal.

- 1. The student may cancel this contract at any time before midnight of the third business dayafter signing this contract.
- 2. All refunds will be made within 30 days from the date of termination. The official date oftermination or withdrawal of a student shall be determined in the following manner:
  - a. The date on which the school receives written notice of the student's intention to discontinue the training program; or
  - b. The date on which the student violates published school policy, which provides fortermination.
  - **c.** Should a student fail to return from an excused leave of absence, the effective date of termination for a student on an extended leave of absence or a leave of absence is the earlier of the date the school determines the student is not returning or the dayfollowing the expected return date.
- **3.** The student will receive a full refund of tuition and fees paid if the school discontinues a Program/Stand Alone course within a period a student could have reasonably completed it, except that this provision shall not apply in the event the school ceases operation.
- 4. The policy for granting credit for previous training shall not impact the refund policy.
